University of Louisville

Title: ELFH 411 Human Resource Foundations

Description: Overview of the field of human resource development in the context of the overall field of HRM, the relationship to workplace performance improvement, and the roles and competencies required in workforce leadership.

IUPUC

Undergraduate Course:

Title: PSY-B388 - Human Sexuality

Description: This three-credit course is a survey of human sexuality to increase knowledge and comfort regarding sexuality in a variety of aspects, i.e. sexual behavior and response, influences of culture and environmental factors, psychological issues, disability effects on sexuality, sexual research, anatomy and physiology.

Graduate Courses:

Title: PSY-G502 - Professional Orientation and Ethics

Description: This course introduces you to the psychological and educational foundations for counseling as well as provides an overview of counseling theories, practices, and organizations. Additionally, this course explores the ethical standards and dilemmas facing counseling

professionals and introduces students to the foundations of ethical principles and ethical decision-making models.

Title: PSY-G523 - Laboratory in Counseling

Description: This course provides closely supervised counseling experiences, i.e., analysis of interviews and role-playing, in a laboratory setting.

Title: PSY-G524 - Practicum in Mental Health Counseling

Description: This course provides students with experiential training in providing counseling services to clients. It includes intensive supervision and instruction to help students develop basic clinical competencies in preparation for their internship experiences. The goal is to help students develop professionalism and proficiency at conceptualizing cases and counseling techniques.

Title: PSY-G532 - Group Counseling

Description: This course introduces students to group counseling. Students will be exposed to a combination of didactic information about groups along with clinical training/skills building that will prepare future group leaders.

Title: PSY-G550 - Internship in Mental Health Counseling

Description: This course expands the experiential training students received in practicum. The course provides a continuing opportunity to apply theory to practice in mental health counseling under direct clinical supervision. Students will engage in a variety of professional activities performed by regularly employed counseling professionals in the setting.

Title: PSY-G552 - Career Counseling

Description: This course covers theories, techniques, and information resources for enhancing vocational development across the lifespan; and facilitating client problem-solving and decision-making related to maintaining balance among work, family, and leisure roles. Students will develop a knowledge base concerning objective and projective methods for exploring and assessing career client interests, skills, and values that inform clients making reasoned career and lifestyle decisions. Current issues/controversies related to ethics, sociocultural factors, and individual differences in career counseling will be examined.

Title: PSY-G563 - Foundations of Mental Health Counseling (Traditional & Online format) Description: This course is designed to explore the foundations and contextual dimensions of mental health counseling. Course material will include theoretical underpinnings of mental health counseling, the counselor's role and responsibilities in the healthcare system, and the contemporary trends in mental health counseling.

Title: PSY-G575 - Multicultural Counseling (Traditional & Blended)

Description: This course evaluates the influence of cultural and diversity factors in counseling theory, research, and practice. The course challenges students to critically examine culture as a multifaceted concept that permeates all levels of human development and experiences. Students will develop skills to evaluate the ways in which their own identities shape their personal and professional lives.

Title: PSY-G622 - Advanced Theories in Counseling

Description: This course reviews the principles of evidence-based practices and the integration of science and practice in mental health counseling. The course assists students in articulating the theoretical orientation that directs their work with clients and incorporates principles of

determining counseling effectiveness.

<u>University of Nevada-Reno (University Study Abroad Consortium)</u>

Title: Internationalization of Mental Health Counseling

Description: Counseling endorses cultural competence as a necessary approach to ethical and competent practices. Yet, counseling theories are rooted in western philosophy of human development, behaviors, and relationships. The course provides students an international experience to develop competencies working with international communities within their cultural context. Students learn how historical and contemporary cultural dynamics influence mental health issues. Student will explore the community's social, cultural, and political climate, learn about the diverse populations, and examine indigenous or culturally-congruent mental health strategies. The program will engage students in critical self-reflection of their own cultural development and evolving professionalism.

Clemson University

Title: Creative Inquiry (Peer Dialogue Facilitators) in Counselor Education

Description: This HEHD Creative Inquiry (CI) will provide undergraduates a unique opportunity to engage with faculty, staff and graduate students as practitioners and scholars. This initiative trains all students as Peer Dialogue Facilitators (PDFs). The Peer Dialogue Facilitator Program has formed in an effort to address the growing demand for intercultural competencies in college graduates. PDFs are a team of undergraduate students whose primary role is to enhance campus climate through programs, which improve understanding, tolerance and communication across social identity groups. In addition to facilitating intergroup dialogue, this team will be responsible for the mediation of conflicts, specifically those targeting social identities, and work with students to achieve mutually beneficial resolutions. PDFs facilitate dialogue for the Clemson student body in an effort to develop essential communication and leadership skills, which are critical for living and working in diverse and inclusive communities.

Title: EDC 810 - Theories and Techniques in Counseling (developed online version) Description: This course provides a survey of the major approaches to counseling. Theoretical models will be contrasted to illustrate breadth, commonalities, and limitations of the different approaches. Additional topics include selected ethical, multicultural, and professional issues facing counselors. Course will be taught through lecture/discussion, video, case studies, and role-playing activities.

Title: EDC 811 - Multicultural Counseling

Description: This course assists students in developing awareness, knowledge, and skills in working with individuals from diverse populations and to fostering awareness of one's own cultural background, beliefs and values that may impact the multicultural counseling process.

Title: EDC 814 - Development of Counseling Skills

Description: On-campus experience to help counselors develop communication skills through role-playing activities, audio and videotaping, interviewing, lecture and discussion.

Title: EDC 815 - Group Counseling

Description: This course acquaints students with group functions and assist students in developing group leadership skills as they related to a variety of group approaches and theories.

Title: EDC 821 – Psychodiagnostics

Description: Emphasis on (1) historical and theoretical perspectives of mental disorders, (2)

diagnostic concepts and frameworks, (3) treatment and intervention models, and (4) application to counseling theory.

Title: EDC 823 - Advanced Counseling Techniques & Skills

Description: This course assists students in developing in-depth counseling skills and techniques for working with a wide variety of populations and/or problems.

Title: EDC 824 – Ethical Issues in Counseling (developed online course)

Description: The purpose of this course is to explore the ethical standards and dilemmas facing today's counseling professionals. The course will include foundations of ethical principles and ethical decision making. Through case vignettes and group work, students will explore ethical issues that cover traditional topics (e.g., confidentiality, dual relationships, & record keeping) and contemporary issues (e.g., multicultural competence & online counseling) that are prevalent in most counseling settings.

Title: EDC 830 – Professional School Counseling Practicum

This course introduces students to the practical issues and the applications of content learned in coursework within the school counseling program through a supervised field experiences in counseling and other services in an elementary school setting.

Title: EDC 836 - Community Agency Practicum

Description: This course introduces students to the practical issues and the applications of content learned in coursework within the community counseling program through a supervised field experiences in counseling and other services in a mental health and community settings.

Title: EDC 840 – Independent Study - Research

Description: This course provides an introduction to and an experience in research methodology. The purpose of this course is to provide students with a systemic, hands-on experience to the components of applied research.

Title: EDC 840 – Independent Study - International Service-Learning Experience Description: This course provides students with an international service-learning experience in Magoye, Africa. The instructor and students will assist the Itamba Secondary School staff and students and the Magoye township in civic and educational projects as assigned. This course is designed to (1) extend the community of "One Clemson" to the country of Tanzania and (2) allow students to apply the theoretical foundations of multiculturalism and their disciplines to international community service.

Title: EDC 844 – Student Affairs Internship

Description: This course provides students with field experience in counseling and other student development activities in a post-secondary setting.

Title: EDC 841 – Elementary School Internship

Description: This course provides students with an immersed, supervised field experience that gives students the opportunity to become familiar and perform a variety of professional activities that a regularly-employed school counselor in an elementary school setting would be expected to perform in addition to direct service work.

Title: EDC 846 – Community Agency Internship

Description: Supervised field experiences in counseling and other services in a community or mental health settings.

Title: EDC 855 – Ethical Issues in Counseling (pilot course for EDC 824)

Description: The purpose of this course is to explore the ethical standards and dilemmas facing today's counseling professionals. The course will include foundations of ethical principles and ethical decision making. Through case vignettes and group work, students will explore ethical issues that cover traditional topics (e.g., confidentiality, dual relationships, & record keeping) and contemporary issues (e.g., multicultural competence & online counseling) that are prevalent in most counseling settings.

Georgia State University

Undergraduate Courses:

Title: GSU 1010 / GSU 1050 - Career Exploration

Description: This course offers students an opportunity to be introduced to the "world of work" and its connection to college life. Students will have the opportunities to explore and connect their interests to college majors and occupational choices. Students will learn how their academic skills and experiences can enhance both their academic success and marketability in the "world of work." This is a goal-oriented course that involves: (a) identifying one's interests, (b) utilizing academic and interpersonal skills and campus resources, (c) researching college majors and career choices, and (d) developing a strategic plan for success.

Title: GSU 1050 - Academic Survival Skills

This course is a course designed to help students improve their academic survival skills. Special attention will be given to the academic, social, family, work, financial, and personal issues that affect student's success in college. GSU 1050 is tailored to meet the individual plan of instruction, and group seminars. Assignments will be designed to cover both general and individual topics related to success in college.

Title: GSU 1060 - Intensive Survival Skills for College Life

Description: This course is designed to help students who have already participated in GSU 1050 and have yet to discover how to be successful in school. The focus of the course is on self-management, providing a framework for attaining academic and personal goals. Students will learn to manage their lives mainly through leaning to manage their affect, behavior and cognitions. GSU 1060 is tailored to meet the individual goals of students through contract plans, group exercises and discussion and outside assignments. Writing exercises will be designed to develop both self-awareness and growth with an ultimate goal of academic success.

Graduate Course:

Title: Multicultural Clinical Practicum (developed new graduate course offering)

Description: This general practicum will focus on the impact of cultural variables in the therapeutic process. The course explores how the cultural development of the therapist and client, as separate cultural beings, influences the dynamics of the therapeutic relationship. The course, emphasizing multicultural counseling competence, focuses on self-awareness, knowledge, and skills as these components pertain to diversity and multicultural issues in counseling. Students will be provided with didactic information and participate in a variety of experiential activities to facilitate their development and growth as culturally effective psychologists.

Title: ECHD 9060 Advanced Multicultural Counseling

Description: This course focuses on the components of self-awareness, knowledge, and skills as

they pertain to race/ethnicity, gender, and sexual identity issues in counseling. The course will provide opportunities for students to examine relevant multicultural issues and to demonstrate their counseling skills in working with race/ethnic, gender, and sexual identity issues.
